### Parent-Studio Agreement with Momentum Dance Academy

This contract is made between the parent and/or student and Momentum Dance Academy (hereinafter referred to as the "studio"). This agreement is for the taking of dance lessons/classes, from the period of **July 25<sup>th</sup> 2011** and ending **June 30<sup>th</sup> 2012**. A yearly, non-refundable registration fee of **\$25.00** is due upon initial sign up. Tuition is based on a set fee for the amount of classes taken a four week period. The studio will collect tuition the **1<sup>st</sup> of every month** for 11 months. The studio will collect a late fee of \$10.00 after the 10<sup>th</sup> of the month, and \$20.00 after the 20<sup>th</sup> of the month. Payments may be accepted by cash, check, credit/debit card, money order or cashier's check. A **\$25.00** fee will be applied per returned check for any returned check. Upon a second returned check Momentum will require a cash, cashier's check or money order within **10 business days of original check date.**

It is the responsibility of the parent and/or student to notify the studio of an anticipated drop of classes or drop from the studio. Failure to notify the studio of a student drop within 4 weeks is subject to a \$25.00 drop fee. **Thursday Dec 1<sup>st</sup> 2011 is the last day to drop a student without incurring a costume fee and recital fee.** The studio reserves the right to collect costume fees in full and recital fees in full for any and all dropped students after the **December 1<sup>st</sup> 2011 deadline.**

The studio reserves the right to collect monthly tuition, based on 4 weeks for 11 months, despite student absences, cancelled classes and/or missed classes due to holidays, studio closure, events, etc. Make up classes are available upon request on a first come, first served basis. The studio will do its best to accommodate your need of a make up class, however there are no guarantees. Parents and/or student will need to make arrangements with the studio for student make ups no later than two weeks following an absence. Make ups are available but are not required. The parent and/or student understands that there will be additional fees throughout the 11 month dance year such as costumes, pictures, recital fees, dance team expenses, etc. The studio will do its best to provide fundraisers to help with expenses, however, there are no guarantees. The parent and/or student acknowledges that any student wanting to participate in recital must have a purchased costume as set by the studio. **A costume deposit of \$50.00 will be required on Thursday October 20<sup>th</sup> 2011 and costume payment in full will be due November 17<sup>th</sup> 2011. A \$15.00 late fee will be applied per month starting December 2<sup>nd</sup> for any and all accounts delinquent in costume fee.** It is the responsibility of the parent and/or student to pay for costumes in full by the set deadline. Any credit earned during this contract term through fundraising is to be used only for dance expenses; costumes, recital fees, competition fees, competition group expenses, etc. There is no monetary compensation of credit at any time. Credit is to be used during the contracted dance year. Unused credit will not roll over into the next dance year.

The parent and/or student acknowledge and agree to the following hold harmless clause as stated below; I (we) hereby agree to indemnify and hold harmless, release and discharge the sponsoring organization of said, Momentum Dance Academy, its agents or contractors, from any and all claims for personal injuries or property damage occurring to or sustained by our (my) child while participating in said dance activities or while in the act of being transported to and from said activity or activities related to dance and including any and all consequential damage claims which I (we) may be entitled to recover from said injury or property damage claim.

The parent and/or student have read this contract in its entirety and have understanding to the set terms. The parent and/or student agree to abide by the terms and policies of this agreement.
